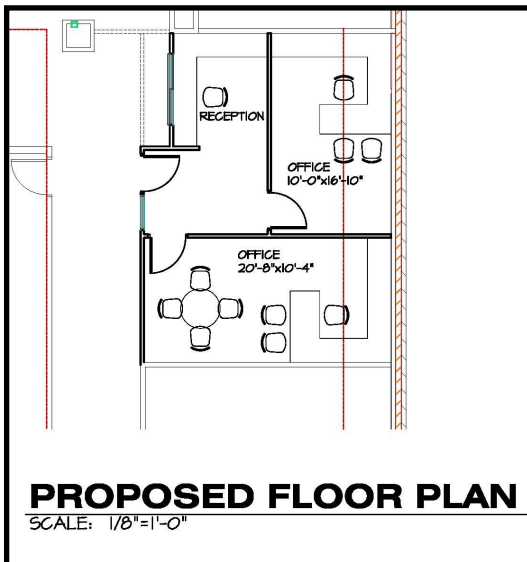

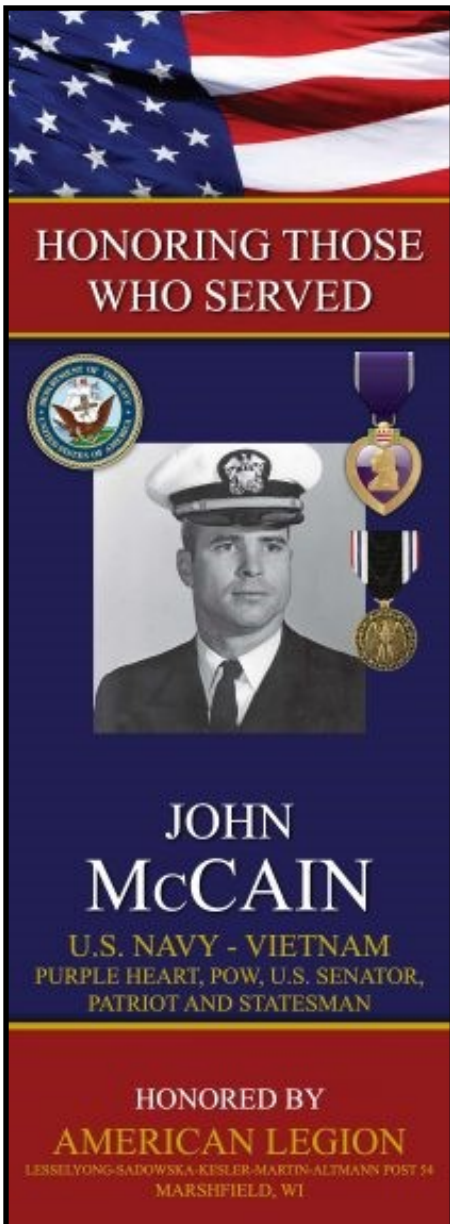


Marshfield Honor Walk

Each banner is 2 feet by 5 feet and is dedicated to one person who had served their country through military service.

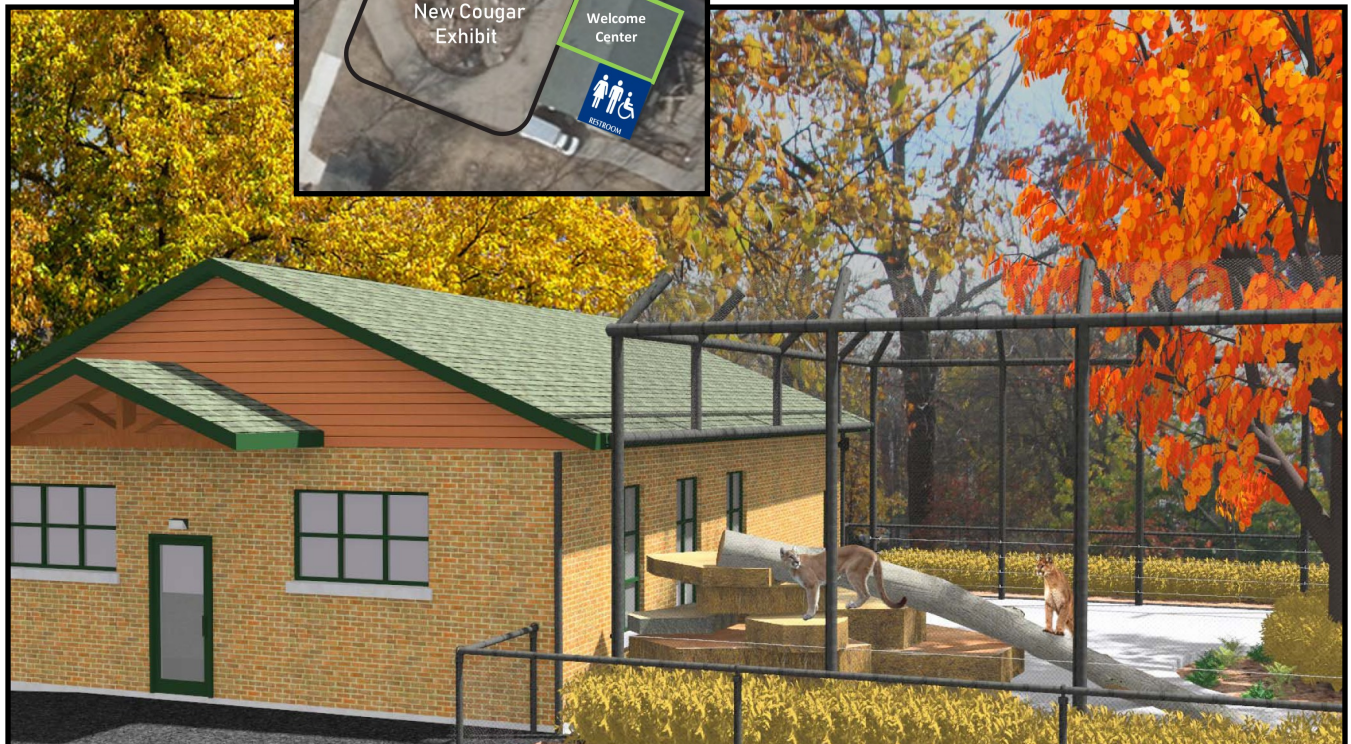
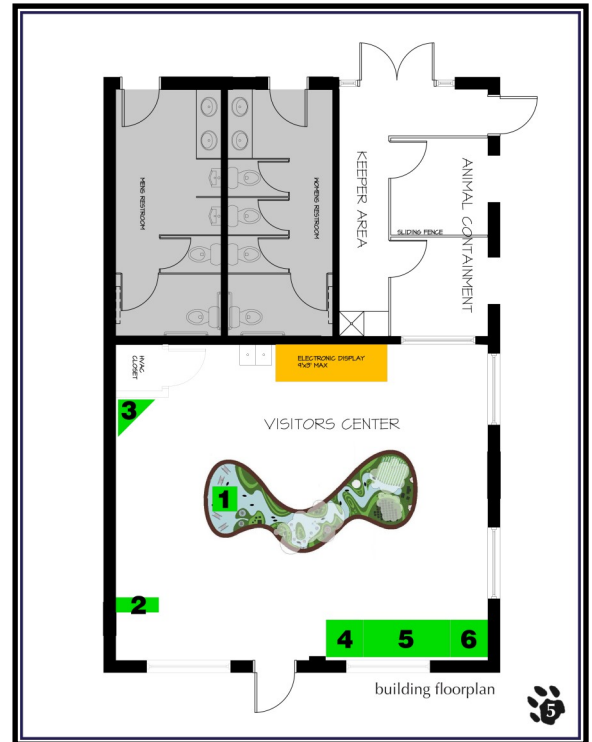
The banners are displayed on each side of Central Avenue from Veteran's Parkway to 9th Street from May 15 to November 15.

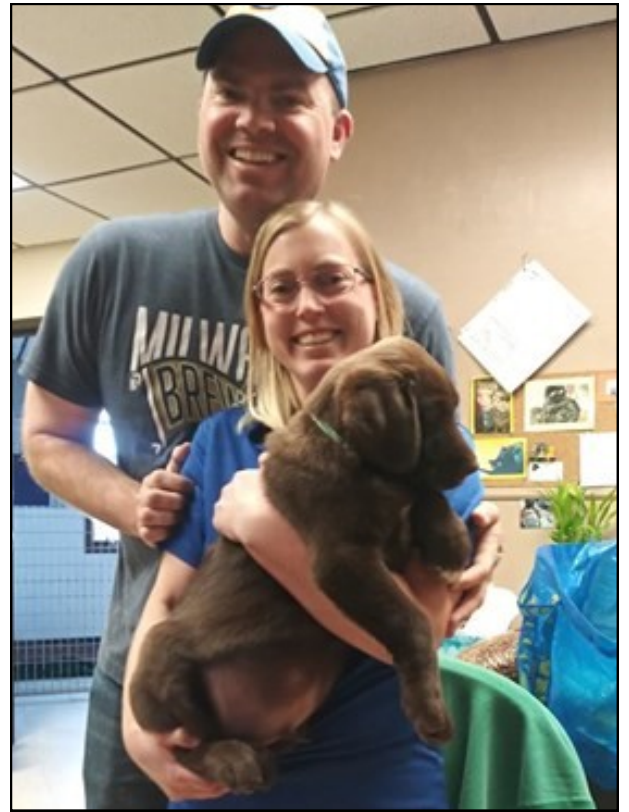

Why should you consider placing your trust in our Community Foundation ?



Community Foundations are public institutions, making grants to improve the quality of life of the people within their geographic location. Community Foundations consist of many separate grant making funds, each established by one or more individuals or organizations. These permanent endowment funds generate income to support charities and projects. The principal is preserved and invested. MACF is a **non-profit organization** with 501 (c)(3) status from the IRS.

Background

Community foundations make up one of the fastest growing sectors of philanthropy in the United States today. Our Foundation is one of more than 500 accredited community foundations in the United States and shares the common goal of serving donors, nonprofit organizations, and the community as a whole. We are accredited through National Standards, and have earned the platinum level for transparency with Guidestar.

Evidence of Excellence: The dollars set aside for charity are limited and precious. The institutions that donors choose to support must be credible and trustworthy. As a symbol of excellence and rigor, the National Standards Seal helps philanthropists and their professional advisers recognize and choose community foundations as a sound place to give and make a difference.

We offer:

Personalized Service: We can make a charitable transfer easy, flexible and effective, helping individuals or non-profits achieve their personal, charitable and financial goals. We are happy to answer their questions and complete all required paperwork; or, we can consult with their financial advisor or estate planner to come up with the solution that's right for them. We can help them establish a fund that may be used to meet ever-changing needs or address a single cause they care about or support a specific agency.

Local Expertise: Our staff and board continually monitor all areas of community need, including human services, education, environment, healthcare, community development and the arts. We also understand the capabilities of local nonprofits addressing these needs. When you give to the community foundation, you know your gift will be put to good use.

Community Leadership: We (board and staff) are leaders helping to make our community better, bringing diverse voices and groups together to address local issues. We foster greater giving and volunteering in our community. And we plan for the future by building endowments to ensure grants support the community forever.

We are a community resource that:

- Encourages philanthropy
- Administers endowment funds and protects those assets.
- Awards creative grants to charitable organizations with the goal of improving the quality of life in the Marshfield area



Ways to Give

- **Outright Gift:** The simplest and most convenient donation is a gift of cash, stocks, bonds, or other property. Your gift qualifies for tax advantages .
- **A Bequest Made Through Your Will:**
You may designate an amount or a percentage of your estate be given to the Marshfield Area Community Foundation for a specific purpose that you choose.
- **Life Insurance:** You may also choose to name MACF the beneficiary of a new or existing life insurance policy.
- **IRA:** The law recently extended the ability to give a rollover up to \$100,000 from an IRA to a charity (if you are 70.5 years old) without recognizing income .
- You may also be able to set up a **Charitable Gift Annuity**, a **Charitable Remainder Trust** or a **Charitable Lead Trust**. Please contact our office for more information.

Types of Funds

- **Unrestricted Funds** provide the Foundation discretion to respond in a timely fashion to worthwhile but possibly unanticipated community needs. Grant requests are solicited in an annual competitive application process.
- **Field of Interest Funds** support a particular area of interest such as education, child welfare, the arts, women's issues, or the elderly.
- **Designated Funds** allow donors to name specific charitable agencies to receive income from your gift. For example, you may choose to provide support for your church, a school, Big Brothers/Big Sisters, Salvation Army, or 4-H.
- **Donor Advised Funds** provide donors an advisory role in the distribution of grants.
- **Acorn Funds.** The purpose of the Acorn Fund is to allow donors to establish a fund in the Foundation with a lesser amount than the required \$10,000 minimum and pledge to make annual contributions to the fund until it reaches the minimum .
- **Project Specific Funds .** This is a type of Designated Fund but of a limited duration. These funds are established to support a specific project conducted by a non-profit organization.
- **Scholarship funds.** Scholarship Funds require unique eligibility and criteria language to be awarded to students pursuing higher education.

Contributions

The Community Foundation welcomes contributions of any size. A minimum of \$10,000 (\$15,000 for scholarship funds) will establish a permanently endowed fund.

Consider Creating a Donor Advised Fund Today!

A donor advised fund is a way for donors to make gifts to charity over time, while receiving the full benefit of giving within the tax year at hand. The donor creates the fund, then participates with the Foundation in directing where those charitable assets should go. In other words, each donor gets to personalize his or her giving. A fund's assets are invested to produce appreciation of principal as well as proceeds for annual grant making. In that way, inflation does not diminish the fund's significance in years to come. 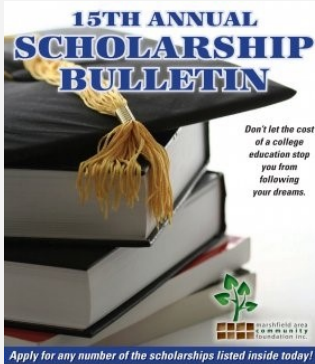

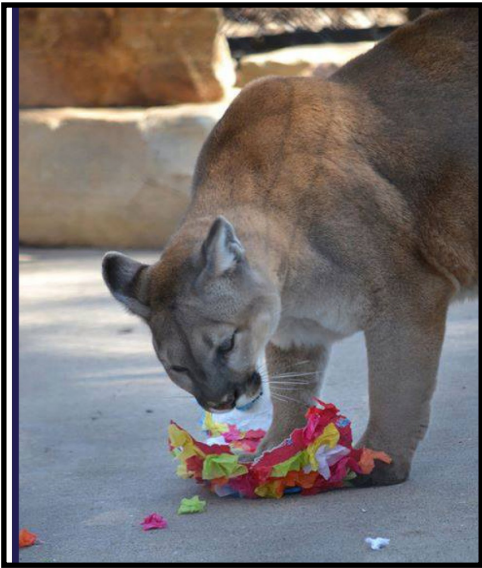

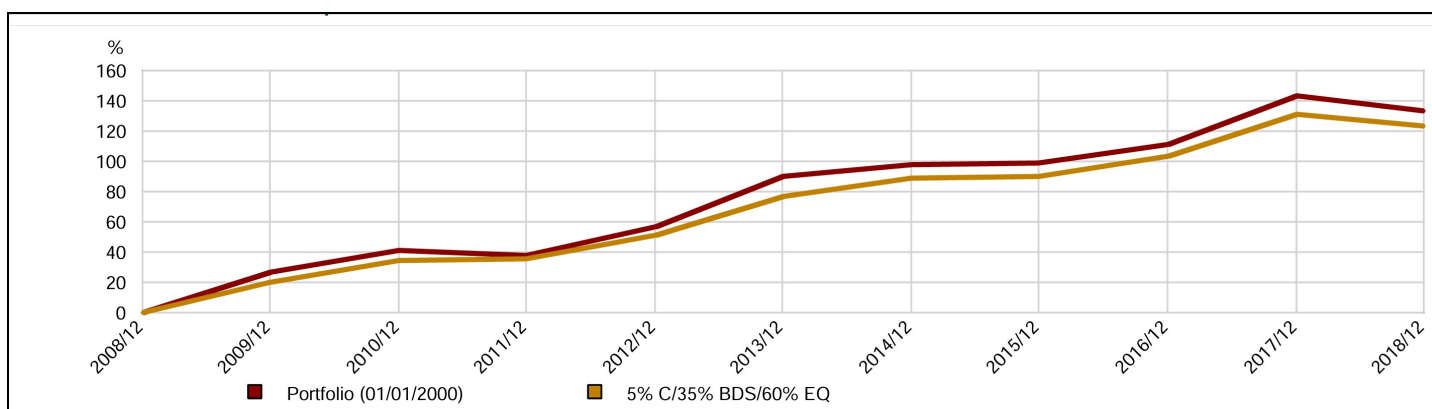


Financial Statements and Investment Returns

In 2018, MACFI saw our community involvement increase exponentially. MACFI is serving as the fiscal agents for the Marshfield Area Pet Shelter, the new Welcome Center and Cougar Exhibit at Wildwood Zoo, the new Lift Up the Arts for the Chestnut Center for the Arts, and the Marshfield Community Athletic Facilities. The Athletic Facilities is the largest project (to date) for which have been the fiscal agent.

The Foundation has grown to over 225 funds and \$16.2M in assets. The Financial Statement for 2018 will be available on our website. In 2018 we gave back \$3.6M to the community bringing the total to over \$26M since we began.

The Investment Policy Statement contains performance benchmarks that the Foundation's investment manager is expected to meet or exceed on a long-term basis, as well as asset allocation guidelines and requirements regarding diversification and quality of investments. The manager's compliance with the Investment Policy Statement and portfolio performance compared to the benchmarks is monitored by the Foundation's Budget and Finance Committee. 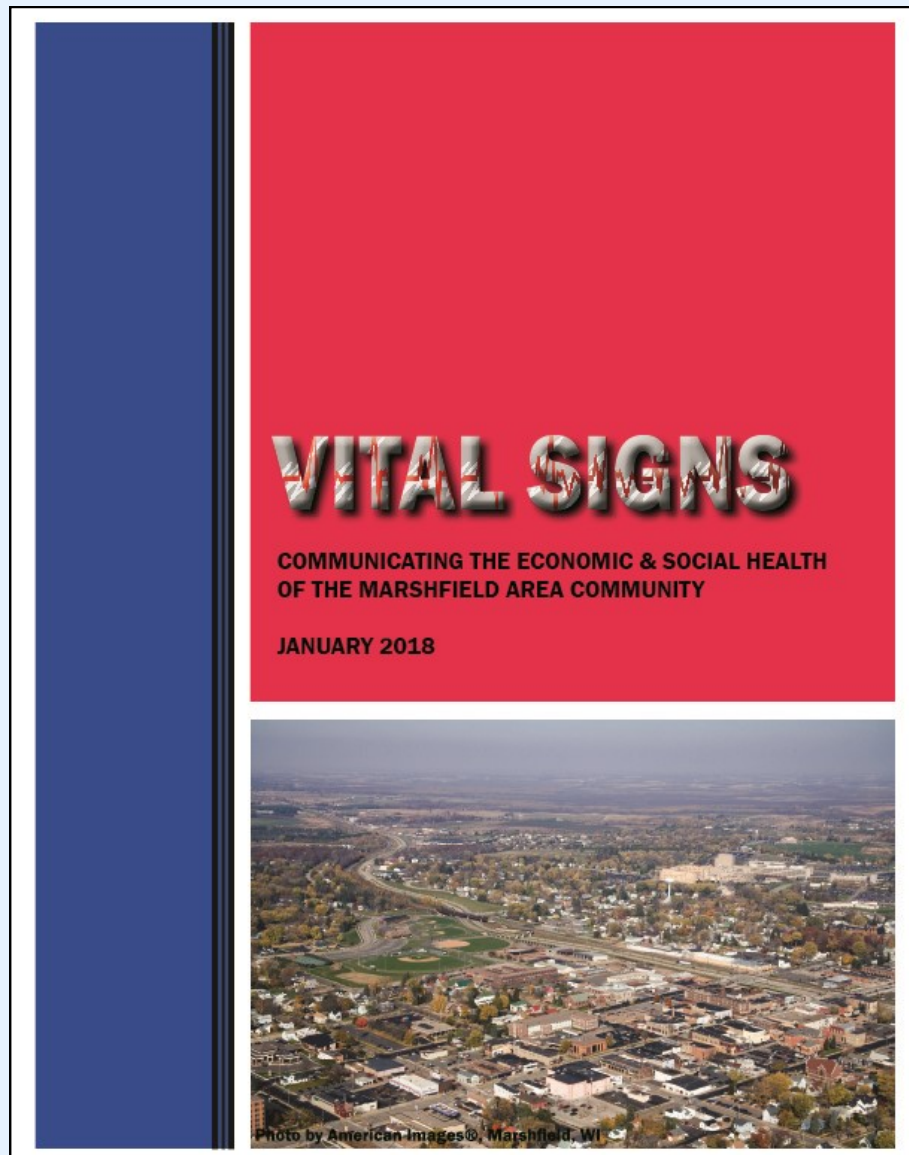

Keep Kids Warm



“Keep Kids Warm” is a program that was started by the Marshfield Area Community Foundation in collaboration with Marshfield Area United Way, to help provide clothing to students in the community who may not have a winter jacket to help keep them warm.

We are seeing alarming changes here in Marshfield. *Vital Signs* reports on the socioeconomic health of our community. We have over 76 homeless children. 1 out of every 5 children, right here in Marshfield, is living in poverty. 26% of our 8th, 10th, and 12th grade students reported that they did not have enough food to eat within the last 30 days.

Our the last five years we have given out new or gently used coats to about 2,000 students who needed a warm coat for our Wisconsin winters.

The need has grown by leaps and bounds.

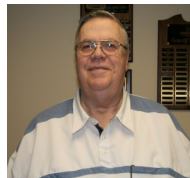

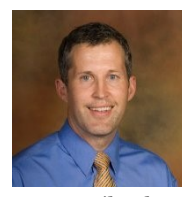
